Once the non-refundable deposit of £150* has been paid, we will confirm your booking via email or otherwise if requested.
- The outstanding balance must be paid 8 weeks before commencement of your holiday. If the booking is made within 8 weeks of departure, the full amount is required.
- A separate £100** will be required as damage insurance/ key deposit, together with the final payment. Provided no damage is caused to the property, this sum will be repaid to you when the keys to the property are returned to us.
- The owners will not be responsible for any force majeure that might affect the holiday, including but not confined to strikes, terrorist activities, war or threat of war, riot, civil strife, industrial disputes, natural or nuclear disaster, construction work, fire or adverse weather conditions.
- We accept no liability for any injuries, death, accident, illness or misadventure incurred during use of the property. We recommend that full Holiday Insurance be taken out.
- Cancellation: 30-55 days before arrival – refund of 50% of payment, less deposit. Fewer than 30 days before arrival – no refund given.
- The maximum number of persons allowed in the apartment is 5 (2-bed)/ 8 (3-bed).
- Representatives of the owners are to be allowed any reasonable access to the property during the Holiday Tenancy.
